What is CCT Africa 2025?

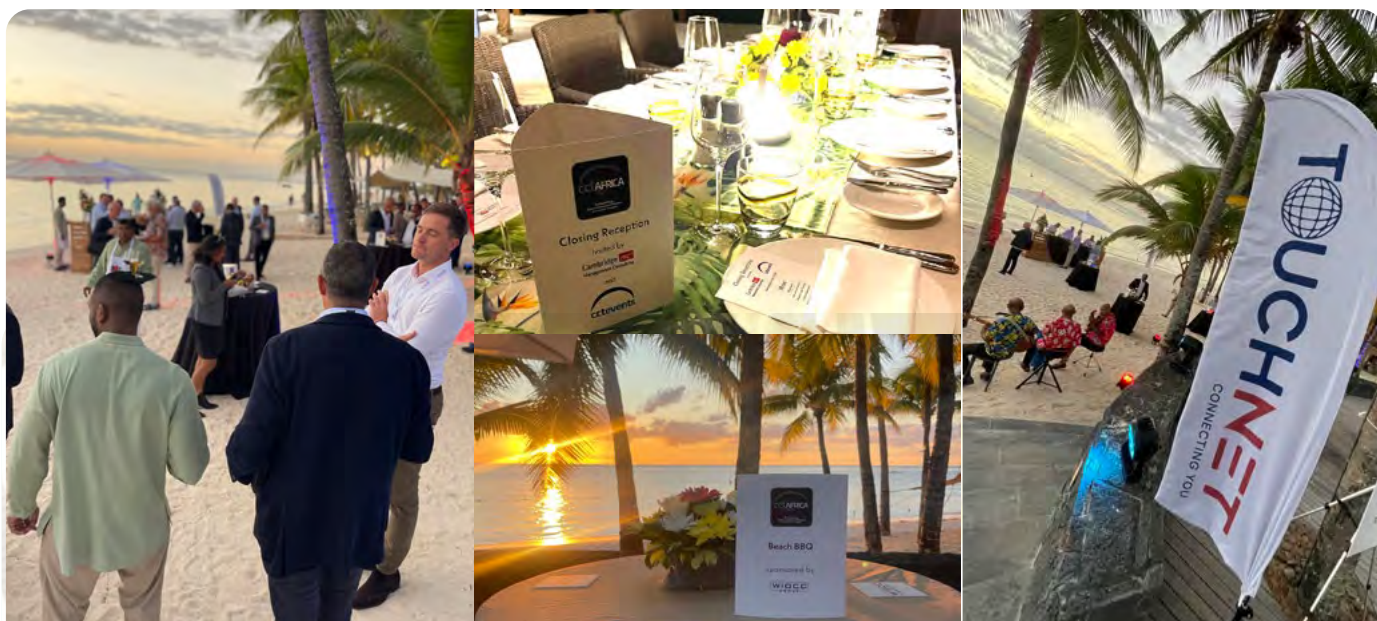
